The challenge

Intimate Partner Violence (IPV) is a form of violence against women which is widespread in Europe and severely affects women's

human rights. According to the European Agency for Fundamental Rights, almost one in four women (22%) experience physical and/or sexual violence in a relationship with a man. Violence is rooted in the unbalanced power relations between women and men, and it is both a cause and consequence of gender inequality and discrimination, which prevent women from equally accessing political, social, cultural, and economic resources and opportunities.

The lack of economic independence is one of the main challenges women face when trying to leave their abusive partner. Anti-violence centres (AVCs) across Europe recognize that women often remain in violent relationships because of their financial dependence on the violent partner. This issue is coupled with the fact that women are considerably underrepresented in the labour market and in decisionmaking positions, with the overall female employment rate still being lower than that of men.

The project

Between 2015 and 2017, the European Union funded the WE GO! project with the goal to strengthen the support services for women

suffering from IPV and to start a European dialogue on violence against women between 15 actors from different countries. **The second edition of WE GO! has started in December 2018** and it takes a further step up, aiming to support the economic empowerment of women who survived violence by strengthening the local and national support systems, exchanging European good practices and establishing cooperation networks between private and public stakeholders.

Our main activities

01. TRAININGS AND MUTUAL LEARNING for professionals/volunteers/social operators of services specialized in supporting women survivors of violence.

02. KNOWLEDGE EXCHANGE between NGOs, anti-violence centres, institutions, experts and private companies.

03. DESIGNING A DEVELOPMENT PLAN FOR 8 AVCS on how to create a network capable to ensure a better economic empowerment for the women they support.

04. CO-DEVELOPMENT OF CUSTOMIZED SOCIAL RELATIONSHIP PLANS, SKILLS ASSESSMENT AND INDIVIDUALISED CAREER PROGRAMMES for 100 women supported by AVCs.

05. AWARENESS RAISING for 80 private companies on how to support women survivors of violence and how to better understand the consequences of violence against women.

06. SUPPORTING 10 COMPANIES to adopt actions and policies aiming to prevent VAW and favour the labour inclusion of women through the **WE GO! Label**.

07. BUILDING MULTI-ACTORS TERRITORIAL PROTOCOLS to ensure the social and economic empowerment of survivors of violence against women.

08. NATIONAL AND INTERNATIONAL PUBLIC EVENTS to disseminate the goals, results and impact of the project.

Capacity Building: To strengthen the social and work inclusion of women survivors of violence.




Network Building: To improve the ability of local support systems to promote the social and work empowerment of women survivors of violence.

- 4 territories with improved coordination and cooperation skills;
- » Civil society organisations, activists, researchers, policy makers from 28 EU Member States benefiting from the project's know-how and tools available on the website.
